# Flavorful and authentic dishes at Carnitas El Jesse

Jesús Flores opened Carnitas El Jesse in April this year, and since then, the culinary gem has been making waves with its mouthwatering carnitas.

Carnitas is a traditional pork dish known for its rich, savory taste and balance of tenderness and crispiness. It involves cooking the pork in lard, a method called "confit," at a low temperature for about four hours. This slow-cooking process renders the fat, making the meat juicy and flavorful.

"There's a lot of work that goes into

preparing the meat, which is why the final result is so delicious," Flores ex-

Flores is an immigrant from Mexico. "I am from the state of Michoacán, and carnitas are a classic dish from there. Michoacán is known for its carnitas. The recipe I use is my own. The secret behind mine and why mine are so popular is that I make them with much love and care."

All the dishes on his menu are based on carnitas. "We make carnitas sopes,



Pastor Paul Hernandez of the Free Will Baptist Church oversees the Matthew 25:35 Ministry Fresh Rescue Program, a weekly food distribution that started in January and has provided roughly 10,000

Before the weekly program, the church held their distributions monthly for the last three years. Several factors inspired the church's long-term commitment to feeding the community.

"First, we saw statistics that said two out of five kids go to bed hungry, and we wanted to find a way to minister to the

food insecurity in our community. Second, we were also looking for a way to minister even through covid," Pastor Hernandez said.

The church receives food from Walmart and other grocers. "They give us food that is close to expiring, and that is why we are allowed to give it away at no cost," he ex-

Using what they collect, they can hand out canned food, meat, deli meat, bakery goods and even pet food. Sometimes, they can give out hot food for those in immediate need. Recently, they have


of Garner's most memorable experiences during this time was at Folsom Prison in 2008, commemorating the 40th anniversary of Cash's performance and live album that was recorded there.



tortas and burritos. The best-sellers are chicharrones, and we have menudo on the weekends with fresh hand-made tortillas. The famous tacos dorados with pico de gallo and seasoned ground beef are also a big hit."

He said what he likes best about cooking is seeing his clients' smiles and seeing them leave content. Cooking is his passion, and he always pours his heart into it.

"My mother was a great cook, and I learned it from her. I inherited her skills as a chef. She taught me recipes, and others I created on my own."

Flores wakes up at 2:30 a.m. to get to the restaurant at 3 a.m. to cook, so that at 8 a.m., when he opens, everything is ready.

"When people say your carnitas are good, they encourage you, and it takes away the tiredness," he said.

They would especially compliment me on my carnitas, which is how I got the

idea to start selling them."

I'd cook all day, and people would come to my house and pick up the carnitas. Then, on Sundays, I rented a space at a market and would sell my carnitas there. With the money I earned, I could save and finally open my restaurant."

The proposed community facilities district shall also finance costs associated with the determination of the amount of and the levy and collection of special taxes which are levied to provide such services and costs otherwise incurred in order to carry out the authorized purposes of the community facilities district.

4. Except where funds are otherwise

available, special taxes sufficient to pay the costs of the services provided for in Section 3 above and the annual administrative expenses of the City and the proposed community facilities district in determining, apportioning, levying and collecting such special taxes, shall be annually levied within the proposed community facilities district. The special taxes shall be collected in the same manner as ordinary ad valorem property taxes are collected and shall be subject to the same penalties and the same procedure, sale, and lien priority in case of delinquency as is provided for ad valorem taxes. However, under no circumstances shall the special tax levied against any parcel subject to the levy of the special tax pursuant to the rate and method of apportionment be increased as a consequence of delinquency or default by the owner of any other parcel or parcels within the proposed community facilities district by more than ten (10) percent. The rate and method of apportionment of said special taxes, which are set forth in Exhibit "A" to the Resolution of Intention, which sets forth in sufficient detail the method of apportionment to allow each landowner or resident within the proposed community facilities district to clearly estimate the maximum amount that such person will have to pay for the authorized

services. 5. Notice is given that on August 6, 2024 at the hour of 6:00 o'clock p.m., in the regular meeting place of the City Council being the Council Chambers of the City Council, located at 336 Pacific Ave, Shafter, California 93263 a public hearing will be held where this City Council will consider the establishment of the proposed community facilities district, the proposed method and apportionment of the Special Tax, and all other matters as set forth in the Resolution of Intention. That at the above-mentioned time and place for public hearing any persons interested, including taxpayers and property owners, may appear and be heard, and that the testimony of all interested persons for or against the establishment of the District, the extent of the District, or the financing of the public services, will be heard and considered. Any protests may be made orally or in writing. WHEREAS, the Board has directed the General Manager to recommend a District budget for the year commencing January 1, 2025, and ending December 31, 2025, as well as 2025 standby charges, 2025 special assessments, and water tolls to be levied by the Board; and

WHEREAS, the General Manager has submitted her recommended budget, a copy of which is available at the District office for inspection, and has made the following recommendations:

1. The amount required to discharge all District obligations for the year

2025 is estimated to be \$14,241,840; and 2. The amount obtained from standby charges is anticipated to

be \$1,767,675 levied on about 19,425 acres at \$91 per acre; and 3. The amount obtained from water tolls is anticipated to be \$9,596,672

based on the sale of 19,109 acre-feet of water within the District's Service Area at an average toll of \$502 per acre-foot; and 4. The amount obtained by special assessments is anticipated to be

\$2,567,731 on about 19,601 acres of land resulting in a toll of \$131 per acre; and 5. The amount obtained by capital special assessments is anticipated

to be \$279,763 on about 1,126 acres of land; and 6. The amount of funds available on the first day of the fiscal year and the amount of miscellaneous revenue

estimated to be collected during the fiscal year is \$30,000; and WHEREAS, Proposition 218 requires the District to hold a majority protest proceeding to adopt an increase in

the District's water toll; and WHEREAS, on September 10, 2015, the Board held a Proposition 218 majority protest proceeding and set the District's water toll at up to \$640 per acre foot. As there will be no

increase in the water toll or change

in its methodology, Proposition

218 procedures for the water toll in 2025 are unnecessary, and in future vears the District reserves the option to implement the approved rate of up to \$640 per acre foot without additional Proposition 218 proceedings; and WHEREAS, on August 11, 2022,

the Board held a Proposition 218 assessment ballot proceeding where the District landowners approved a standby charge of \$91 per acre and additional Proposition 218 procedures for the standby charge are therefore unnecessary; WHEREAS, in connection with an

assessment ballot proceeding that the District conducted on August 11, 2022. District landowners approved a special assessment of \$122 per acre subject to increases based on the Consumer Price Index (CPI-U); and

WHEREAS, the annual application

of CPI-U to the special assessment results in a special assessment of \$131, and additional Proposition 218 procedures for the special assessment are therefore unnecessary; and WHEREAS, in connection with a special assessment ballot

proceeding that the District conducted on March 14, 2024, specific District landowners approved a special assessment of \$59,445 per year for the Avenue 24 Capital Improvement Project; and WHEREAS, in connection with a special assessment ballot proceeding that the District conducted on March 14, 2024, District specific landowners approved a special assessment of \$220,318 per year for the Quinn Pumping Plant and Pipeline Capital Improvement Project; and

WHEREAS, the Board finds and determines that it is in the best interest of the District for the Board to declare its intention to adopt the budget, implement the recommendations of the General Manager, and call and notice a public hearing.

The Board of Directors of KERN-TULARE WATER DISTRICT resolves as follows: Each of the matters set forth above

is true and correct and the Board so finds and determines. The Board declares its intention

to (a) adopt the recommended budget for 2025 (b) fix and charge water tolls of up to \$548 per acre foot for water delivered by the District (c) levy and collect 2025 standby charges of \$91 per acre upon land being offered water service by the District, (d) levy a special assessment of \$131 per acre on all land within the District, and (e) levy special assessments that cumulatively total \$279,763 on certain benefited parcels within the District.
