# County accepting bids for new park

Kern County Public Works is accepting bids for a new park in Shafter, according to a statement from Public Works Director Joshua Champlin.

The park will be the first such project in the La Colonia area of Shafter, formerly known as the Mexican Colony.

The area is steeped in tradition, with residents going back generations. For

years, residents have been wanting improvements or revitalization done in the southern part of Shafter.

Thanks to funds from the American Rescue Plan Act, \$330,000 was given to fund creation of the La Colonia Community Park. Engineering and design phases for the county project are complete.

The project will include amenities such as basketball courts, picnic tables, water

fountains and landscaping. If additional funds are available, exercise equipment may be included.

Michelle Burns-Lusich, senior manager for construction services with Kern County General Services, said that the park project is going to beautify the area and give the residents a park that is more accessible to them in the neighborhood and will be a great addition to the community. "We hope to have the project completed by February 2025," she said.

The park will be a welcome sight for residents who have been wanting one for

"This is going to be great," said Monica Hernandez, who lives in the area with her mother and two children. "We can't wait to be able to use the park, so close to home ,and will be beautiful from what everyone

The location of the park will be near Burbank and Mannel Streets and will also include lighting and a sidewalk path.







A Shafter woman who tried to intervene in an altercation in Bakersfield was hit by a vehicle and is in critical condition at a local hospital. Shelli Fuller was driving on Knudsen Drive at approximately 4 a.m. on Thursday morning when she observed

an altercation taking place. She reportedly exited her vehicle and tried to intervene in the altercation. Fuller was then struck by a vehicle and critically injured. The driver of the vehicle initially fled, but later contacted police to report her involvement.

Investigators said that multiple peo-

ple were involved in the incident. Upon arrival, officers found Fuller in the roadway, suffering from severe injuries. The investigation is ongoing and anyone with information in this case should contact the Bakersfield Police Department at 661-

Fuller is a mother of two daughters, Ashlyn and Hailey, and is currently in the intensive care unit. Her prognosis is uncertain at this time. Ashlyn said, "We still are unaware of any of the specific details or even who committed this act, but the woman who did this is still able to live her

normal life while ours is falling apart." Ashyln Fuller has created a GoFundMe page for her mother, at gofundme.com, Aid Shelli Fuller.

In the beginning, it was the Gossamer Condor, followed by the Albatross and the solar-powered Solar Challenger. Emceed by KGET's Jim Scott, the celebration included a silent auction, dinner and speeches by three of the pilots of the aircraft.

Bryan Allen, who was the pilot for the Condor, spoke at the event. Allen said that he was so thankful to be a part of this amazing group and felt lucky to be a part of it. "It was an amazing feeling, up in the air, and I can't say enough about the wonderful people who made it possible." Allen and the group, headed up by Paul

McCready, won the British Kremer Prize, offered to the group that created the first human-powered aircraft that completed a figure-eight route that spanned one mile. McCready was an aeronautical engi-

neer that founded the company AeroVironment. He took his inspiration from hang gliders, increasing wing area so that the drag of the wire bracing needed would be reduced. The Gossamer Condor is built around a large wing with a gondola for the pilot underneath and a canard control surface on a fuselage extension in front, and is mostly built of lightweight plastics with aluminum spars.

Janice Sullivan, a grade-school teacher from Bakersfield, was the pilot of the solar-powered Challenger. Sullivan had acquired commercial and glider pilot credentials.

Sullivan's diminutive stature, Sullivan said, was probably a key to her being selected as the pilot for the test flight. "I was only 98 pounds, so I think that had a lot to do with my being chosen. But, no matter the reason, it was one of the most exciting experiences of my life."

The evening was full of reminiscing by the group, many of which were seeing each other for the first time in decades.

The field representative for Assemblymember Jasmeet Bains presented Allen, Sullivan, Sam Duran and Pierce with proclamations recognizing their accomplishments.


never been involved in the



# Pierucci gets his 100th win against Exeter

The Shafter High Generals football team began their 2025 journey with a win against the Exeter Monarchs on Friday

# A place for lonely places

I don't need to tell you that we live in a pretty fast-paced culture. Whether it's getting from one place to another, receiving or sending information over the internet or simply trying to keep up with the latest news, it's fast!

Sometimes the pressure of trying to "keep up" in some way can really wear us down. The culture that Jesus was born and raised in was much different from the U.S.
