### Frank Russell closes after nearly 85 years

Shafter lost another icon this week when Frank Russell, Inc. closed its doors

on Tuesday. Opened in 1939, the shop has been serving the community, meeting fabricating and steel needs for almost 85

Owner and operator Andy Russell said that it was time to do it, and said that he will miss his loval customers. "It was a family decision. I just decided that it was

the right time. I am 73 years old and am ready to spend more time with family."

Andy's father, Frank Russell, moved to Shafter in 1935 with \$228 to his name. He began working for Al Nikkel at Nikkel Ironworks. In 1936, a partnership was formed between him and Bill Isaacs. The Isaacs and Russell shop was located where the Shafter Depot Museum stands today Russell and Isaacs repaired potato

optic system. "Most businesses have to install their own fiber optic networks, but with Shafter, it is already there."

Add to this the large number of new homes being built in Shafter, including the Gossamer Grove development, Marcona Estates and Willow Estates. All together, another 2,500 homes are planned, and with that growth, also comes the need for commercial businesses in the area. Although they have not been named, national retailers have an interest in the Gossamer Grove area, he said.. In addition to the commercial development, there are already plans for a Shafter Police substation there, along with a Fire Department unit, and in the future, schools too.

Guerra said that it is very exciting to be a part of this growth and the unfolding story of the city.

### Rescues make Shafter's animal shelter bare

The Shafter Animal Shelter has a unique situation when it comes to city animal shelters – they have a shortage of adoptable dogs at the site.

In the past six months, the shelter has not put any pets available for adoption on their website. This is due to the rescue partners that the city deals with, accounting for all of their available dogs. There are some cats available, however, as they are not rescued.

Recently, the shelter had a dozen dogs

in the shelter, but all but one of them were designated for rescue. The animals are transported to the rescue organization, where they will be sent to foster homes to be cared for until they are matched up with a suitable home.

The one dog that was in the shelter not designated for the rescue was an owner/ surrender animal, with the owners not being able to care for the animal because it had escaped from the home numerous times.



### Council OKs 2-year labor pact with cops

The city has come to a labor agreement with the Wasco Police Officers Association for the next two years, including 4% wage increases this year and in 2025.

The agreement also includes bilingual pay, POST certificate, education, and other pay incentives, along with details on holiday pay.

In addition to the WPOA-covered employees, the same benefit provisions are extended to Police Department employees outside the bargaining unit who are not on an employment contract.

The total cost for the memorandum of understanding agreement is covered in the city's 2024-25 budget.

#### WASCO

"I am happy that the Wasco Police employees formed the WPOA so they can get some of the legal protections that come with the membership," Police Chief Charles Fivecoat said Tuesday night.

Councilmember Vincent Martinez said the pact was key to building a solid department. "I am excited we were able to come to an agreement with our newly formed police union. My goal is to be fiscally responsible with the city's money but also be fair to our employees.

Compensation packages are important when it comes to recruitment and retention. I feel this package is fair to both the city and our public safety employees." Also at the meeting, Chief Fivecoat reported on the Wasco Police Department's activity in June compared to May. Total incidents in June came in at 1,465, a decrease from 1,572. The June breakdown was 863 calls for service and 602 officer-initiated incidents, while in May, there were 829 calls for service and 743 officer-initiated incidents.

Councilmember Gilberto Reyna said, "People **Lieutenant Alecio Mora** are very pleased with the

work you and everybody in the department are doing.'

new Citizen's Rims online interactive tool, which is designed to help members of the public become aware of police activity and some department services.

"It helps us with transparency and information sharing," MOra said. "It's a user-friendly interface that will help us work together with the community to detect and prevent crime. Some of the features include a missing persons tab, a record of stolen vehi-

"She also taught us if you're going to say something, you need to do it and follow through. There was no quitting."

Cynthia Huffman said her mother's perspective on life has influenced her and her family. "I think how my parents stayed together is important growing up. We had faith in our family and a religious belief growing up."

"Also, that our parents were always there for us. We could turn to them for help and advice with anything. They were people who would support us when we needed it, and we felt that love throughout our lives."

At her birthday party at the Wasco Woman's Club, she had family fly in from South Carolina, Virginia and Nebraska. About 80 people attended the party, and all of them enjoyed her sense of humor.

"She can still communicate easily with people, walk around and enjoy life and her friends."

Cynthia flew with her on her birthday, and the airline was very sweet, she said. "They made a big deal about her in the terminal and on the plane by singing happy birthday to her. She thought that was a big deal and a lot of fun. It was special to have strangers sing to her to celebrate her 100th birthday."

Huffman said she will be around as long as she can. "As long as she is enjoying life, she will be happy to try to reach the next 101, 102 and so on," her daughter said.

### Officer Cook: Building trust and service

With the launch of the new Wasco Police Department, the men and women in uniform leading the force are passionate and committed to protecting and serving the community. Police Officer Anthony Cook is one of them.

"We are here to protect you, to serve you and we are here to provide the services that you asked us for," he said in an interview this week.

Cook thinks that adaptability is the most important quality for a police officer to possess. "Laws are always changing, community opinion is always changing and law enforcement policies are always changing. And we as officers must navigate those changes and still provide quality service."

As a newcomer to the community, he plans to engage with and build trust among residents. "I plan to continue to reach out to community members and business owners on a personal basis, not through my job as an officer but in random encounters on or off duty – and continue to grow those personal relationships with community members."

He stated that it is the leadership and the officers that that lhey brought onto the force which sets the WPD apart from others. "They all do a great job. Tthey teach

us, they guide us and they all have a wealth of knowledge."

It has been a journey for him to get to this point as an officer. "When I was trying to get into the police academy, it was very competitive. I applied four or five times until I sponsored myself through the Hanford College of Sequoia Academy. I worked full-time during it, Monday through Thursday at work and Friday, Saturday and Sunday I was at the academy, for 11 months with no vacation and no time off. Just work, school and a family."

He said that Wasco is a small town but doesn't feel small. "Everyone is friendly. You can have a conversation with anyone. They seem very friendly toward law enforcement and happy we are there. You can ask any officer, and they will tell you that on a daily basis, we get thanked for being here and told you guys are doing a great job. We have positive feedback every day."

Cook believes that the main focus of modern policing is community relationships. "It's what our chief {Police Chief Charles Fivecoat] tells us every day, and it should be natural to every officer.

He added that his values align with what the department wants. "Which are positive services, positive law enforcement contacts and to enforce the laws."

diggers and other implements for local farmers. The partnership was dissolved in 1939, and Frank bought property and constructed a new shop downtown. The original shop now houses the retail agricultural and industrial hardware store.

Over the years, they have sold Goodyear tires, Oliver Tractors, potato planters, Russell Rolovators and Russell cotton trailers, among other items.

Frank was dedicated to serving the community, and not just in his place of business. Russell also was police commissioner for a time and served on the City Council.

Andy Russell began managing the store in 1974 and, with his son Cody, have continued to build the company into a Shafter institution.

Russell grew up here and said that he just loves its people. "It is a community filled with wonderful

people," he said. "My son graduated from Shafter High in 1997 before he headed off to Cal Poly San Luis Obispo] to get his degree. Shafter is just a wonderful place to live."

### From patient to practitioner: Dr. Padilla

Dr. Francisco Padilla of Padilla Physical Therapy and Fitness is a doctor of physical therapy who runs his business with his wife, Diana. He established his practice last year, in 2023. He was inspired to enter his profession because he was a patient after an automobile accident that almost cost him his life.

"I was in an accident driving home one day on Sept. 3, 2012. I hit a power pole, and the car caught fire. I burned 80% of my body, had 30 surgeries total and was at the hospital for ten and a half months at the Fresno Burn Unit at Community Regional Medical Center. I was motivated by a physical therapist who helped me, and that got me into this career."

He started his education with an associate degree from Bakersfield College, then a bachelor's from Fresno State, and earned his doctorate in Nashville, Tenn., at South College in Knoxville.

Padilla opened his clinic in Wasco because he thought the community needed quality health care and wanted to provide that service.

"There were no physical therapy clinics in town. When I was growing up, I knew most of the community. It was very difficult for them to commute out of town to Shafter, Delano or Bakersfield, and a lot of time, they would not get therapy or a way to get better, so I decided to open the clinic here."

The Wasco native provides a wide range of services. "We provide physical therapy for people that just need general strength training due to age or injuries. We help people after they have surgeries, whether knee replacements, shoulder operations, carpal tunnel, anything that has to do with post-op."

"We help with any rehabilitation and work with athletes, helping cheer, soccer, football and baseball players, all from Wasco High. We work with a variety of patients, older ones that need balance, who have had a stroke or deal with sciatica pain, anything that has to do with the human body and function."

About his business, he said, "It's a lot of work, but if you're passionate about it, it's all worth it. If I could change one

According to Karlina Gomez, an animal control officer for the department, the animals have a very quick turnaround from arriving at the shelter to being transported to their rescue homes.

When asked why the shelter decided to put so many of their dogs into the rescue, Gomez said that it is really in the best interest of the animals. "Honestly, we were getting frustrated because we would adopt an animal out and would see it back at the shelter in a month or two."

Gomez said that the owners wouldn't

follow the instructions given by the shelter staff, and don't have any sort of training in how to care for the animals. "The owners would bring the animal back because they either changed their mind, or didn't realize how much time and care it takes to raise a pet, so we would get it back at the shelter." She also said that it is more difficult to adopt the animals out once they have left the shelter and then brought back. "A lot of the times they are not socialized, so they may not get along with the other animals, or maybe they weren't encouraged to listen to commands and trained properly."

This philosophy does help the dogs who are in the shelter find a suitable forever home once they have been fostered and found a good family to go to, Gomez explained. But to some, it seems like a snub of the community.

"I love dogs and have looked on the website at the adoptable dogs for the past two months and haven't seen any. I don't think that it is right that they assume that all residents would make bad pet owners and don't give them a chance to have a new family member," said resident Rosa

Ramirez. "My kids were wanting a dog for a long time but we ended up getting a dog from a shelter in Bakersfield because we could never find any at the Shafter shelter."

According to Nick Riddick, animal control officer, there is a wish list that they have for residents who are looking for a specific breed of dog. "If we get a certain kind of dog in the shelter and it matches one that is on the wish list, we will contact the prospective owner to set up a meeting."

On June 25, 2024, the Kern County Board of Supervisors enacted Franchise Ordinance F-703.

Franchise Ordinance F-703 granted California Resources Production Corporation ("Grantee") a 20 year non-exclusive franchise, replacing Ordinance F-465, as amended by Ordinances F-519, F-557, F-566 and F-593, to construct, install, maintain, inspect, operate, repair, renew and remove non-public utility pipelines and power pole lines together with the appurtenances and equipment necessary or convenient for operation thereof. The actual external diameter of the pipeline, including casing, rounded to the closest inch, shall not exceed twenty (20) inches. The principal purpose of the franchise is the transport of oil, natural gas, and produced water and the transmission of electricity for proprietary use. The requested franchise covers all areas in and under any and all public highways, public roads or rights of way now or hereafter dedicated to public use for roadway purposes and expressly accepted and/or declared public highways by the County (including, but not limited to, the Kern County right of way for Poplar Avenue, Shafter Avenue, Beech Avenue, Kimberlina Road, Dresser Avenue and Merced Avenue), which are within the County of Kern, and are within Sections 20, 21, 27, 28, 33 and 34, Township 27 South, Range 25 East, M.D.B.M.; Sections 1, 2 and 3, Township 28 South, Range 24 East, M.D.B.M.; and Sections 2, 3, 4, 5, 6 and 23, Township 28 South, Range 25 East, M.D.B.M., but not included within the limits of an incorporated

#### city. Throughout the term of the franchise the Grantee and its successors or assigns shall pay to the County an annual franchise fee equivalent to \$1.55 per cubic foot for each of Grantee's pipelines and

\$1.00 per linear foot of Grantee's pole lines installed in County right of way. This franchise fee shall be adjusted annually, pursuant to Section 8 of the Ordinance. Grantee shall file with the designated agent of the Board of Supervisors, within three months after the expiration of the calendar year or fractional calendar year following the date of the granting of the franchise and within three months after the expiration of each calendar year thereafter, a detailed and verified statement showing the location (by road name or number and section, township and range), length (expressed in feet) and size (expressed in inches) of all of Grantee's pipelines and pole lines situated within the County right of way. Grantee shall pay to the County, within 15 days after the time for filing the statement described hereinabove, in lawful money of the United States, the annual fee due.

Any neglect, omission or refusal by Grantee to file the verified statement, or to pay the franchise fee at the time or in the manner provided, shall make the Grantee subject to penalties and/or constitutes grounds for declaration of forfeiture of the franchise and of all rights, thereafter, as detailed in Sections 11, 13, and 14 of Ordinance F-3 (Fourth Revision). The application of Grantee, the franchise ordinance and related documents are on file with the Clerk of the Board of Supervisors, Kern County Administrative Center, where they may be examined during normal business hours.

I took him for a ride to try to see if it would help him. I stopped at a dog park to let him do his business, and he somehow hurt himself on the hill at the dog park, injuring his back. He ended up with a compression of his spine, and I lost my best friend. So, excuse me if I am a bit extreme on this subject.

There is also the addition of alcohol that really seals the deal as a really bad idea. It is a great idea to start lighting up fireworks, grenades that you can hold in your hand, while being half-lit yourself. That is a great combination. It is a wonder that there aren't more injuries and deaths than there actually are every year. I wish that we could do away with the "safe and sane" fireworks and enjoy the shows put on by those who know what they are doing, and hopefully, sober.

### PASTOR'S CORNER Freedom in Christ

The founding fathers of the United States had strong beliefs about freedom. The Declaration of Independence states, "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the Pursuit of Happiness." They believed that their human rights were given to them by the Christian God of the Bible, not to be violated or taken away by government (Genesis 1:27).

Freedom is a human right on many different levels: political freedom, freedom of religion, freedom of expression, economic freedom, freedom of thought, freedom of self-determination and more. The Bible had a profound impact on the ideals of freedom that began our country.

It was predicted that the Messiah, Jesus, would bring freedom and restoration from spiritual bondage. He would *"proclaim free-*

dom for the captives and release from darkness for the prisoners" (Isaiah 61:1). This tremendous liberation was from empty religion, sin, and death. Jesus said, "So if the Son sets you free, you will be free indeed" (John 8:36). Jesus offered freedom in salvation from sins for those who believed in His name (John 3:16). The apostle Paul "Through explained, Christ Jesus the law of the Spirit who gives life
